ORDER

On August 13, 2020, RPA Energy, Inc., dba Green Choice Energy (RPA), applied for a license to operate as an alternative gas supplier (AGS) in Michigan pursuant to 2002 PA 634, MCL 460.9 *et seq.* (Act 634). As part of its application, RPA provided information to demonstrate compliance with the AGS license requirements set forth in Act 634 and the Commission's March 12, 2003 order in Case No. U-13694 (March 12 order) establishing the AGS licensing procedure.

Act 634 requires an AGS to have the necessary financial, managerial, and technical capabilities to serve customers within the state of Michigan. ¹ In accordance with the March 12 order, the Commission Staff (Staff) must review the application of the prospective AGS for

conformance with Act 634 and with the Commission's orders. The Staff then must recommend appropriate action regarding that application to the Commission.

Upon review of RPA's personnel descriptions and histories, the Staff observed that RPA currently provides natural gas and electricity to customers in Pennsylvania, Ohio, Illinois, Maryland, the District of Columbia, Delaware, and New Jersey. The staff further observed that RPA's key personnel have extensive experience in the energy industry, including expertise in risk management, load forecasting, nominations and scheduling, commodity procurement, and marketing. The Staff also found that RPA is equipped to respond to customer inquiries and complaints in a timely manner through its current quality assurance team, taking complaints from their toll-free number, and email. Based on its review, the Staff has determined that RPA has sufficient experience and expertise to serve customers in Michigan's Gas Customer Choice Program. The Commission agrees.

RPA provided the Staff with a bond in the amount of \$100,000. Based on its review of the audited consolidated financial statements and the satisfied bond requirement, the Staff determined that RPA's financial capabilities and availability meet Act 634 requirements. The Commission agrees.

Act 634 requires RPA to maintain an office within the state of Michigan.² RPA's Michigan office is located at 250 Monroe NW, Ste. 400, Grand Rapids, MI 49503. The Staff determined that RPA has met the office requirements for licensing. The Commission agrees.

The Staff has reviewed RPA's license application and information. Based on this review, the Staff recommends that RPA be granted a license to operate as an AGS in Michigan.

Based on RPA's submissions and the Staff's review, the Commission finds that RPA's request to be licensed as an AGS is reasonable and in the public interest, and that it should be approved. The Commission further finds that the AGS license should be conditioned upon compliance with all of the applicable provisions of Act 634, the Commission's orders and administrative rules, and each of the delivering natural gas utilities' tariffs. Failure to comply with any of these provisions may result in revocation of the license or other penalties.

THEREFORE, IT IS ORDERED that:

- A. RPA Energy, Inc., dba Green Choice Energy, is granted a license as an alternative gas supplier subject to the conditions contained in this order.
- B. RPA Energy, Inc., dba Green Choice Energy, shall comply with the regulatory requirements specified in 2002 PA 634, MCL 460.9 *et seq.*; the Commission's orders and administrative rules; and each of the delivering natural gas utilities' tariffs.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, pursuant to MCL 462.26. To comply with the Michigan Rules of Court's requirement to notify the Commission of an appeal, appellants shall send required notices to both the Commission's Executive Secretary and to the Commission's Legal Counsel.
